### **4.1 Description of first aid measures**

<b>Eye</b>	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.
<b>Inhalation</b>	If inhaled, remove from contaminated area. Apply artificial respiration if not breathing.

Alternatively, mix with flammable solvent burn in an incinerator fitted with afterburner and scrubber. Prevent environmental contamination as aquatic life may be threatened.

### 16. OTHER INFORMATION

**Additional information** **RESPIRATORS:** In general the use of respirators should be limited and engineering controls employed to avoid exposure.
